2018 Program Results

During 2018, EMERGE provided services to 2,854 participants. Of all participants with a program enrollment, 1,885 (50%) participants had a New Program Enrollment during the year. Of those served during 2018, 95% identified as people of color with the largest groups served African American (59%) and African (24%). Our participants are 96% low-income with 80% under the poverty-line.



746 gained 972 jobs



272 participated in career training



274 accessed financial education or coaching



79 worked toward their GED/Diploma, while 25 were enrolled in college courses



115 received skills training through our Enterprises

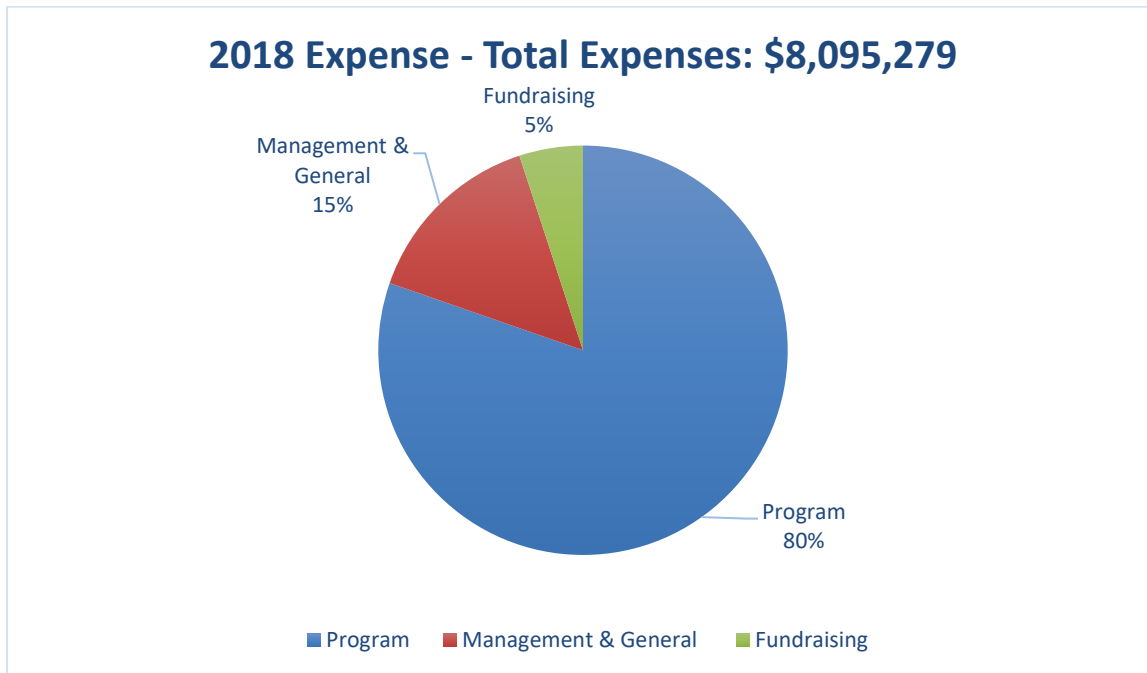
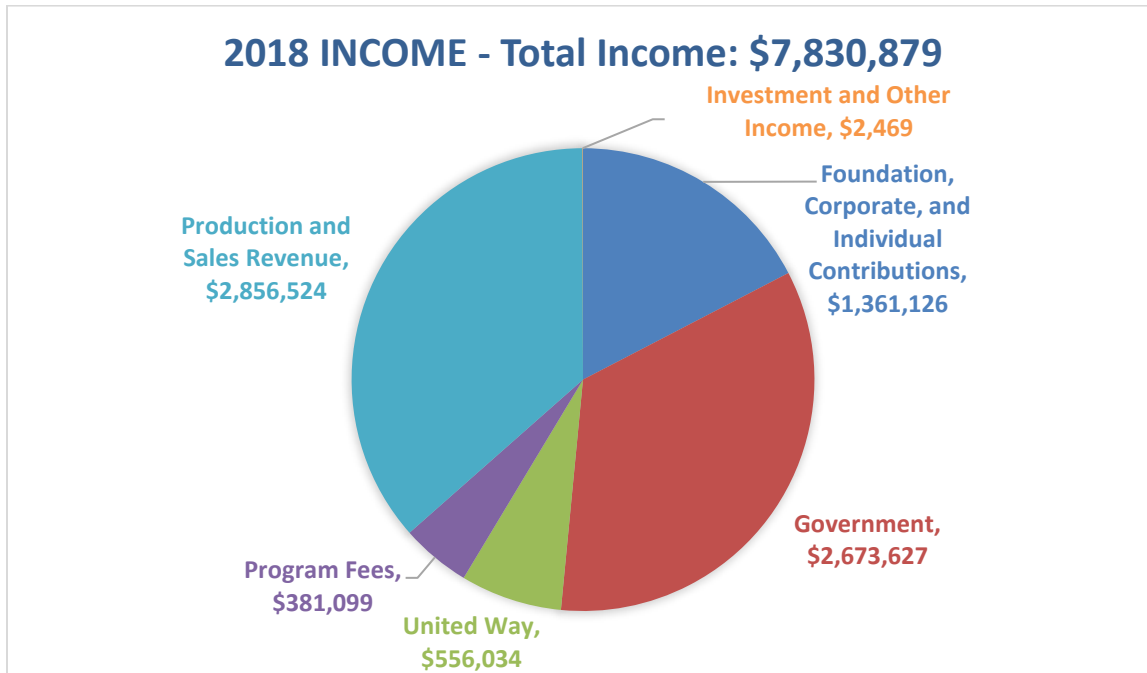
1,133 participants received \$310,071 in support services
